CALMING THE CLAIM DENIAL RIPTIDE

STRATEGIES FOR MITIGATING INCREASING CLAIM DENIALS



Jeff Nieman, CEO, Meduit

In the first three months of 2023, approximately one-third of inpatient and outpatient claims submitted by providers to commercial payers went unpaid for more than 90 days. Many were outright denied.

Claim denials that were once reserved for a sliver of expensive medical treatments have become a more common occurrence for ordinary medical care. Current payer practices combined with Al and computer algorithms are denying claims by the thousands every month.

Impact on Reimbursements & Margins

Our revenue cycle management customers report that insurance denial rates have increased significantly in the post-COVID-19 world, negatively impacting reimbursements. This escalation of denials is causing huge administrative burdens for hospitals, health systems and physician groups.

Furthermore, the demand for staff to work aged insurance and denials has increased. With labor costs growing across the board for providers and vendors, these competing pressures result in reduced margins and even operating losses for some.

Options for Reducing Denials

There are really only two options for

starting to beat the payers at the denials game:

- Build Al in-house via your internal IT
 team and deploy it with your existing
 staff. Providers need to be using Al
 aggressively to automate billing, claims
 follow-up and the appeals process in
 order to increase the response times
 and throughput to match that of the
 payers who have added significant
 utilization of Al over the past couple of
 years.
- Partner with an expert denials resolution vendor who is using similar automation and can add staff and automated throughput to increase your current capacity.

INCREASE CYBERSECURITY IN HEALTH CARE WITH SAFETY-BOOSTING STRATEGIES

A devastating health care cyberattack hit Change Healthcare on February 21, 2024. By forcing the \$13 billion company offline, the cyber criminals cut one of the few connections between health care providers and payers, triggering a cash crunch at medical groups, health clinics, hospitals, and pharmacies.

This cyberattack left many health care providers struggling for cash and facing serious consequences. Even now, a second ransomware hacker is attempting to extort Change Healthcare based on the data exfiltrated during the initial attack. The breach also brought to light the vulnerable nature of the industry's infrastructure. As one of the largest health information exchange platforms in the US, Change Healthcare's ransomware attack disabled providers' ability to access the data and systems used to process prescriptions, claims, and payments creating a trickledown effect that significantly impacted all parties.

As entities that process and store vast amounts of valuable data, including personally identifiable information (PII) and other health information that can be used for insurance and identity fraud, health care organizations are increasingly targeted. The data is not only highly valuable, but it is necessary to provide services to patients. These two factors combined make ransomware attacks one of the biggest threats to health care organizations.

Below are some cybersecurity strategies your organization's leaders can use to mitigate risks against cyberattacks and safeguard your digital assets and patient data.

Safeguard Your Digital Landscape

The Change Healthcare breach highlights how one key failure can cause massive disruption. Improve your organization's cybersecurity strategy, recovery plans, and continuity capabilities by incorporating the following activities.

Review Cybersecurity Insurance

Cybersecurity insurance or a captive insurance group can provide coverage for a wide range of cybersecurity incidents.
Reviewing your policy to clarify terms and covered incidents, such as cyberattacks that occur with a vendor or a vendor's vendor, can bolster your overall security plan.

Insurance claims are typically slow to pay out making this a less than optimal solution, but knowing what is and isn't covered can

HOSPITALS SHOULD EVALUATE HOW CMS RULING 1498-R3 AFFECTS MEDICARE SSI PERCENTAGES

A new ruling from the Centers for Medicare & Medicaid Services (CMS) changes the way a provider's Medicare fraction is calculated for periods prior to October 1, 2004 —it's now solely based on total days, without the option of covered days.

CMS Ruling 1498–R3, issued March 4, 2024, revokes Ruling 1498–R2 and applies to each properly pending claim in a disproportionate share hospital (DSH) appeal or open cost report, including those involving patient discharges predating October 1, 2004.

Inpatient hospitals will need to evaluate open and pending appeals prior to October 1, 2004, and look at how SSI realignments are impacted.

Who Is Affected by Ruling 1498-R3


The ruling affects inpatient hospital cost reports two ways:

 Medicare DSH payments with open or properly pending appeals for Cost Reports starting prior to October 1, 2004 Pending or new SSI Realignments for Cost Reports starting prior to October 1, 2004

Background on Ruling 1498-R3

The ruling, issued March 4, 2024, deals with the Medicare SSI percentage as it pertains to the Medicare disproportionate share hospital (DSH) calculation. The Medicare SSI percentage is calculated and published annually by CMS and has been the subject of litigation for decades.

CMS notes Ruling 1498-R3 is needed to comply with the Supreme Court ruling in



Becerra v. Empire Health Foundation, for Valley Hospital Medical Center that evaluated the Medicare statute as it relates to the Medicare SSI percentage.

What Changes with Ruling 1498-R3

CMS Ruling 1498–R2 is revoked, which means SSI percentages are now calculated on total days, not covered days.

CMS Ruling 1498-R2 Is Revoked

CMS previously issued Ruling 1498–R2 on April 22, 2015. This ruling amended Ruling 1498–R issued April 28, 2010, and allowed hospitals to choose between two methods for calculating the Medicare SSI percentage for use in the Medicare DSH calculation.

The difference between the two methods revolved around the treatment of the non-covered Medicare Part A days and days for beneficiaries who have exhausted their Medicare Part A benefits.

SSI Percentage Now Calculated on Total Days Method Only

Any open cost year or properly pending appeal on the SSI percentage issue for cost reports beginning prior to October 1, 2004, will be settled using the total days method.

This method will include patient days for Medicare Part A beneficiaries for noncovered services as well as patient days for beneficiaries who have exhausted their Medicare Part A benefits in the denominator of the Medicare SSI
percentage, and to the extent the same
patients are entitled to SSI benefits, the
same days will be included in the numerator
of the Medicare SSI percentage.

Next Steps with Ruling 1498-R3

Hospitals should evaluate the impact on the Medicare DSH calculation for any open or pending appeals for years beginning prior to October 1, 2004.


Hospitals should also evaluate the impact on any previously requested or future requests for SSI realignments to the cost reporting year end for periods beginning prior to October 1, 2004.

LEADERSHIP RETREAT


April 11-12, 2024

Unfortunately, many healthcare provider teams do not have the internal staff or financial resources to build AI technologies internally. That leaves choosing and partnering with the right vendor as typically the best solution.

Tips

Before selecting a denials management firm with significant Al automation capabilities, ask the following questions:

- What processes does the vendor employ to review data, remit data, and determine and classify the nature of denials?
- What is the vendor's track record for appealing and overturning denials?

 Can the vendor help institute process improvements for claim submissions that will reduce future denials?

To effectively research and fix denials, the right vendor should:

- Provide proper verbiage in the submitted claim
- Manage the appeal process
- Deliver denial analytics and transparent reporting back to your system

Ideally, the vendor should utilize EDI billing data (ANSI 276/277 and 835) to determine whether claims were paid correctly. Next, they should remit that data into the healthcare provider's proprietary system so the organization can benefit from that information.

inform insurance strategies, including the use of a captive insurance company, which can reduce insurance premium costs and maximize pay-outs on claims in emergency situations.

Increase Resilience and Build Contingency Plans

To support IT and business resilience, assess your third-party vendor risks and establish backup or contingency contracts with other transaction processors to diversify your organization's pipeline.

Also review where your organization fits in the overall processing software and systems chain. Use this holistic view to create an effective plan for outage events. The ability to fail-over to another processing provider, with contracts and processes already in place, can allow operations to continue with minimal interruption.

Improve Cybersecurity Posture & Remediate Third Party Risk

A proactive approach centered on identifying weaknesses and the areas breaches can occur can boost your organization's cybersecurity. Essential proactive measures include regular risk assessments, vulnerability management, incident response planning, and testing response and recovery plans. Risk assessments should include an assessment of third-party risk, which can identify dependencies and potential weaknesses with the third party.

Employee Training

Employee error remains a major factor in

cybersecurity incidents that lead to breaches. Comprehensive cybersecurity training programs should involve all employees, from executives to IT staff and include topics like:

- Phishing scams
- Social engineering tactics
- Secure password practices

Simulated phishing and vishing attacks to assess awareness are highly recommended as these exercises mimic tactics, techniques, and procedures of an attacker and helps evaluate the cybersecurity maturity of your controls.

Next Steps

In the wake of the Change Healthcare attack, it's recommended that organizations complete an IT security risk assessment at the minimum to assess potential exposure and vulnerabilities that could further impact operations.


