

Tennessee HFMA's Kelly Miller Road Show was named for Kelly Miller, a healthcare professional who dedicated her time and effort to HFMA before her untimely death in 2014 at age 32.

Kelly was born and raised in Bristol, TN and attended the University of Tennessee where she received her BS in business administration with a major in accounting. After being exposed to the world of healthcare finance through an internship with a local accounting firm, Kelly decided this is where she wanted to focus her career. She went on to earn her Master of Science in Healthcare Administration and MBA from the University of Alabama, Birmingham.

After college, Kelly worked for several CPA firms in Nashville, TN where she focused on Medicare/Medicaid cost reports and other third-party reimbursement issues for hospitals and other healthcare facilities. She built a reputation by presenting on various reimbursement topics to organizations such as HFMA, the American Health Lawyers Association and the American Society of Women Accountants.

Kelly was a Certified Healthcare Financial Professional and a Fellow with HFMA. She also served on the board of directors for Leadership Health Care and was treasurer for Hearing Bridges. As an active member of the HFMA Tennessee Chapter, Kelly was instrumental in developing the "TN Road Show", which continues to be a popular event throughout our state.
