
The Importance of Our Vendor Sponsor Partnerships

Vendor Summit Structure



- Held bi-annually, in conjunction with SC HFMA Fall and Spring Institutes
- Inaugural Summit: October 22nd, 2024



- Presentations by accepted vendors
- Structured networking sessions
- Facilitated discussions
- Agreement to provide a minimum of two (2) warm introductions



Eligibility Requirements



- Vendors must be at least a Gold level sponsor of SC HFMA
- Bronze and Silver sponsors may apply
 - If Accepted, Vendor agrees to upgrade to Gold or President chapter sponsor level



• Each application must include a provider recommendation, demonstrating your impact and effectiveness as a partner



- Accepted vendors will pay an additional \$1,500 to participate, ensuring a highquality, productive environment for all attendees
 - First year fee is \$750 for October 2024 Summit
